**FEEDBACK REPORT: COMPLIANCE INSPECTION: METAL RECYCLERS ASSOCIATION (MRA)**

The Section: Liquor and Second-Hand Goods Services conducted a national compliance inspection in terms of the Second-Hand Goods Act, 2009 (Act No. 6 of 2009), hereafter referred to as "the Act", at the office of the Metal Recyclers Association (MRA) situated in Brackenhurst, Gauteng Province, on 06 December 2023.

The compliance inspection focussed on the implementation of the provisions of the following governance:

- Second-Hand Goods Act, 2009 (Act No. 6 of 2009); and
- Regulations for the Accreditation of Second-Hand Goods Dealers' Associations, 2010.

The following initiatives are noted and appreciated:

- The compiling and printing of a catalogue in relation to targeted commodities at State Owned Entities, such as for example Eskom, Telkom and Transnet, to be utilised by MRA members during the identification of possibly stolen commodities;
- The electronic inspection system which were developed for specific use by MRA members with the aim of replacing the conducting of physical inspections at MRA member premises with a system-based inspection process.


